FM 2252 - Evans Road to FM 3009

The Texas Department of Transportation (TxDOT) will host an open house on Wednesday, September 27, 2017, to present proposed improvements to FM 2252 from Evans Road to FM 3009. The proposed project would expand FM 2252 from a 2-lane to a 4-lane roadway with raised median or continuous left turn lane plus bike lanes, curb, and sidewalk. The proposed project would replace the existing bridge over Cibolo Creek and also provide an overpass at the Union Pacific Rail Road crossing.

Open House

Anyone interested in the project, is invited to attend the open house public meeting. There will be no formal presentation, so attendees can come and go at their convenience. Attendees will have the opportunity to view schematics of the proposed improvements, visit with team members, ask questions and share their comments on the project.
